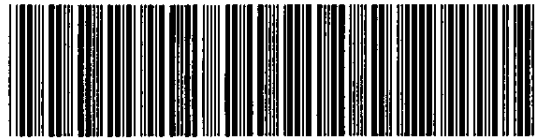

OF

ARTICLE I

NAME:

The name of this limited liability company is **G-FORCE FITNESS & BOOTCAMP, LLC** (the "Company").
