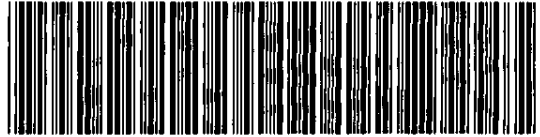

registered agent or the location of its registered office, or both, from time to time without amendment of these Articles of Organization.


ARTICLE V
