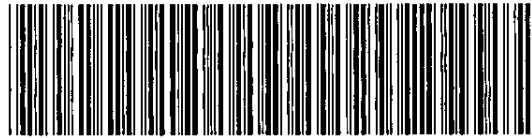

The mailing address and street address of the principal office of the Company is 3245 Jack Road, Laurel Hill, Florida 32567.


ARTICLE III - INITIAL REGISTERED OFFICE AND AGENT
