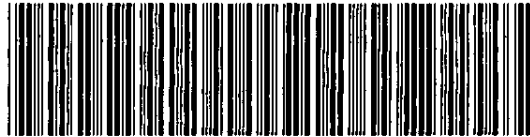



ARTICLE I


