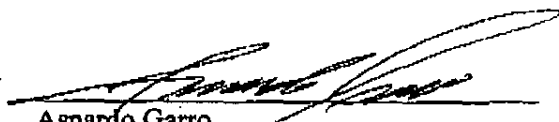
**ARTICLE VII**
