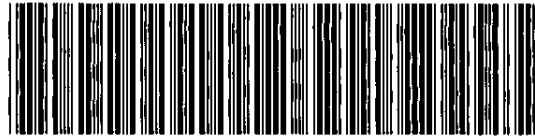

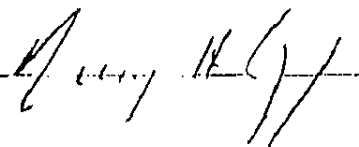
1. The name of the Company is 1125 Capital, LLC.
