KNOW ALL MEN BY THESE PRESENTS: That We, Todd Kempinger and Scott Bafts ORIDA desiring to form a limited liability company for the purposes set forth herein and in conformance with the Florida Limited Liability Company Act, do establish:

- 1. <u>Company Name</u>. That the name of the limited liability company is **HospitalityFirst Services L.L.C.**
