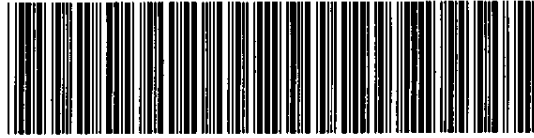





The name of the Limited Liability Company is Bay Colony Realty Associates, LLC.


ARTICLE II - ADDRESS




