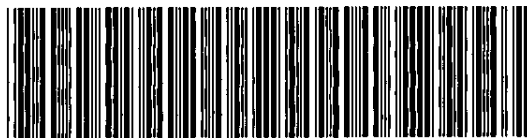

The name of the Limited Liability Company is Communities Home Builders, LLC.






