The name of the limited liability company is: M3 Dynamics, LLC.

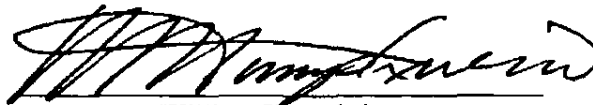
**ARTICLE II. ADDRESS**
