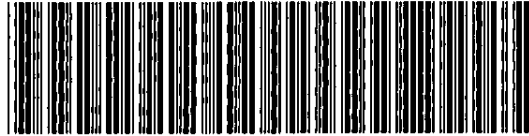

The name of the Limited Liability Company is Gateway Communications Services, LLC.






