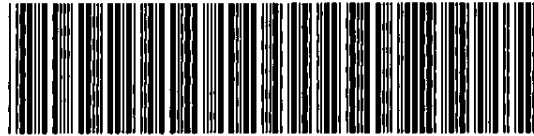

The name of the Limited Liability Company is Community Specialized Services, LLC.


ARTICLE II - ADDRESS




