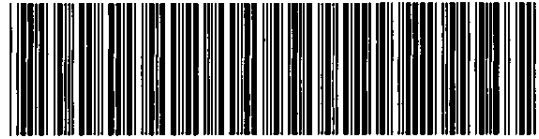



The name of the Limited Liability Company is WCI Amenities, LLC.




