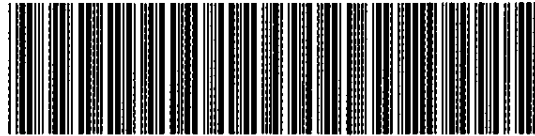



The name of the Limited Liability Company is WCI Business Development, LLC.




