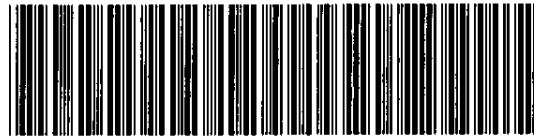





The name of the Limited Liability Company is WCI Homebuilding, LLC.


ARTICLE II - ADDRESS




