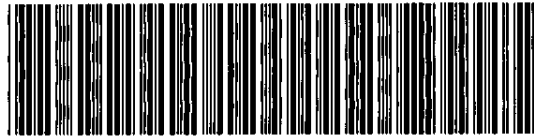



The name of the Limited Liability Company is WCI Ireland Inn LLC.






