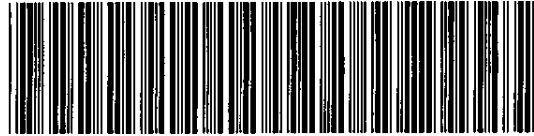

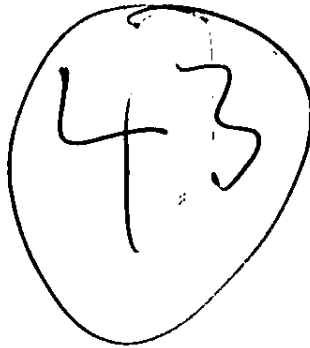



The name of the Limited Liability Company is WCI Marketing, LLC.






