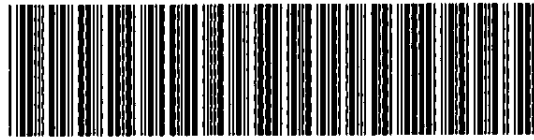





The name of the Limited Liability Company is 2009 Coral Ridge Properties, LLC.




