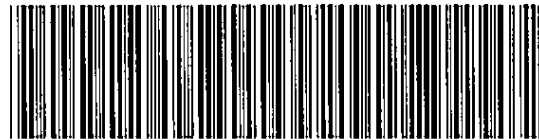





I previously submitted the enclosed articles of amendment for N & T Distributing LLC, and a payment by check of \$25.00 for the filing fee.
