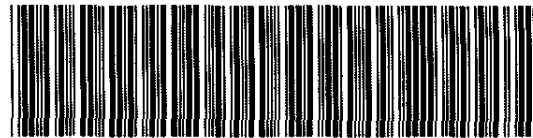

**ARTICLES OF ORGANIZATION OF

MANAGEMENT**

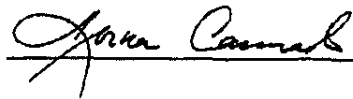
This is a manager-managed company; therefore, management of this limited liability company is reserved to one manager, whose name and address are as follows:
