# ARTICLES OF ORGANIZATION FOR MCGONIGLE REAL ESTATE HOLDINGS, LLC

#### ARTICLE I - NAME

## ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS

The members of the Limited Liability Company shall be permitted to admit additional members upon approval of members owning at least ninety (90%) percent of the outstanding Member Units of the Limited Liability Company. Notwithstanding the foregoing, the Board of Managers and Members owning at least ninety (90%) percent of the Member Units of the Limited Liability Company may consent to a distribution. All distributions shall be in the form of insurance company annuity contracts with the respective member as the annuitant, unless the Board of Managers and Members owning at least ninety (90%) percent of the Member Units of the Limited Liability Company consent otherwise.
