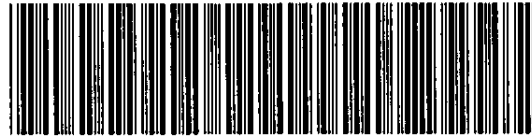

1. The name of the limited liability company is 1900 SCENIC 98, LLC (the "Company").

Tampa, Florida 33605."


4. Article 5 of the Articles of Organization of the Company is hereby amended to read as follows:
