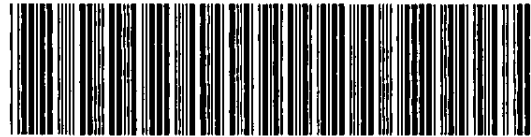




A special meeting was held on July 2, 2012 at 8:30 am at Panama City Bch, Florida. All shareholders were present.


