ARTICLES OF ORGANIZATION

of

LOGAN MANAGER, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME AND ADDRESS

The name of the limited liability company shall be Logan Manager, LLC (the "*Company*"). The mailing and street address of the principal address of the Company shall be 9252 San Jose Boulevard, #902, Jacksonville, Florida 32257.

ARTICLE II

PURPOSES AND POWERS


