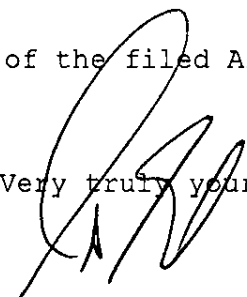

ARTICLE I
NAME

The name of this Limited Liability Company is **PICKETT CABLE STAY SYSTEM, LLC**.

ARTICLE II
DURATION

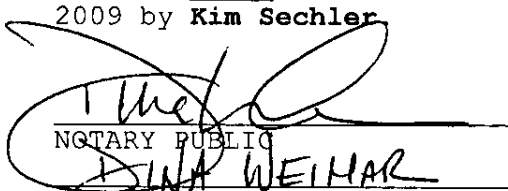
