#### ARTICLES OF ORGANIZATION

# CHC CHAPEL TRACE GP, LLC

The undersigned, acting as the organizer of CHC CHAPEL TRACE GP, LLC, under the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopts the following Articles of Organization:

## ARTICLE I - Name:

The name of the limited liability company is CHC Chapel Trace GP, LLC (the "Company"

# ARTICLE II - Address:

The mailing and street address of the principal office of the Company is 161 St. Anthony Avenue, Suite 820, St. Paul, Minnesota 55103.

# ARTICLE III - Duration:

The period of duration for the Company shall be perpetual, unless dissolved in accordance with the terms of the Operating Agreement of the Company.
