Registered Office and Agent

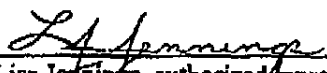

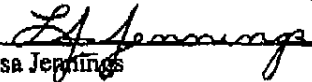
CERTIFICATE OF DESIGNATION OF
