The name of the Company is 239 Bella Group, LLC.

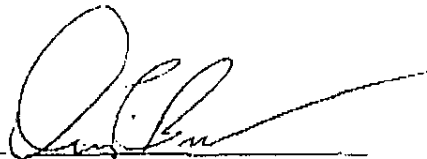
**ARTICLE II
