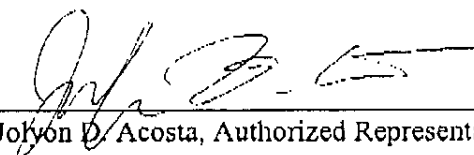
ARTICLE V

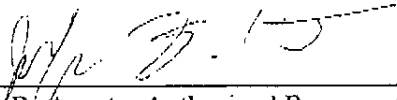

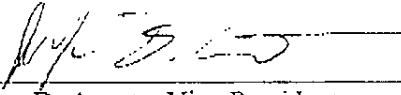
