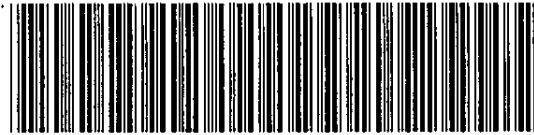



The Limited Liability Company is formed for the purpose of acquiring, managing, holding, and disposing of real property and other assets held for investment.


