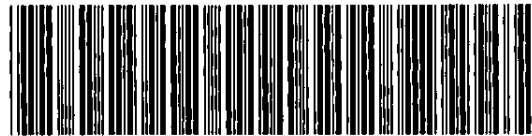

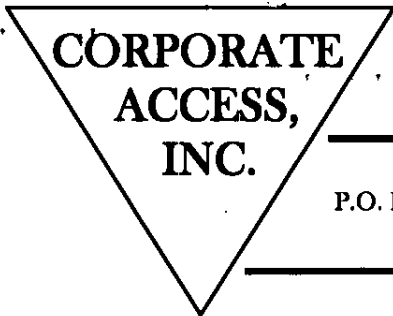


ARTICLE III — REGISTERED AGENT AND REGISTERED OFFICE:
