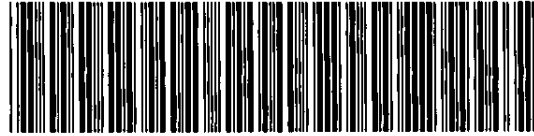


**ARTICLE III — REGISTERED AGENT AND REGISTERED OFFICE:**
