




Article I is amended to read as follows:

2. The foregoing amendment was adopted by the shareholders and directors of the corporation on February 18, 2000.

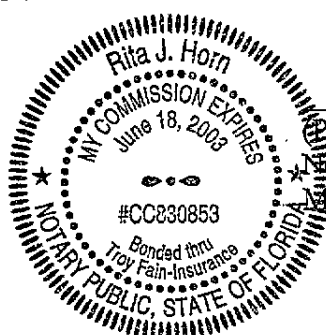


