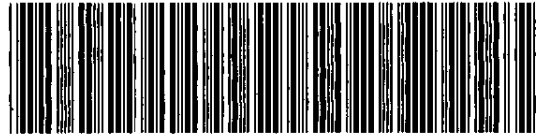




ARTICLE VII.



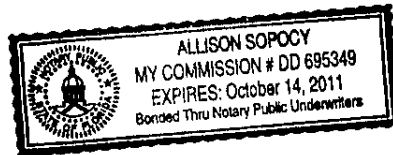
