

ARTICLES OF ORGANIZATION

OF

AD INVEST LLC

The undersigned hereby forms and organizes a limited liability company pursuant to Section 6014.407 of the Florida Limited Liability Company Act (the Act) and adopts the following Articles of Organization of AD INVEST, LLC (the Company):

ARTICLE I

NAME

The name of the limited liability company is AD INVEST, LLC

DURATION
