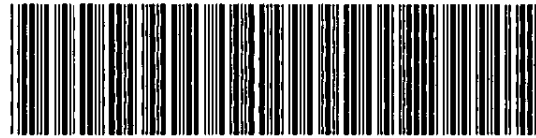



NAME
