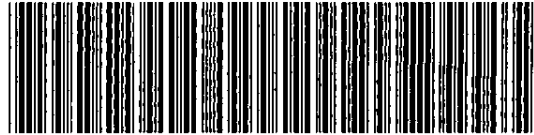

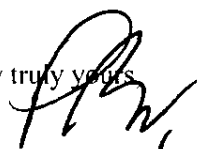

**ARTICLES OF ORGANIZATION
OF
BONUS McCABE, PLLC**

The undersigned natural persons, who are licensed and otherwise legally authorized to practice law in the State of Florida, for the purpose of forming a limited liability company in accordance with the Professional Service Corporation and Limited Liability Company Act, Chapter 621, Florida Statutes, hereby make, acknowledge and file the following Articles of Organization.

ARTICLE I

Name. The name of the limited liability company shall be **BONUS McCABE, PLLC** (the "Company").

ARTICLE II

Purpose. The purposes for which the Company is formed are:

a. To engage in the specific business of the practice of law as a professional limited liability company and to carry on services incident thereto. Such practice of law is the sole and exclusive professional service to be rendered by the corporation;

b. To invest its funds in real estate, mortgages, stocks, bonds or any other type of investment;

c. To engage generally in the business of a law as a professional limited liability company as the same is now or hereafter defined by statute, rule and regulation, and in connection therewith to own real or personal property, to enter into contracts, and to transact any lawful business related thereto;

d. To engage in such other business incidental to the practice of law as a professional limited liability company as may be authorized or permitted by Florida law;

e. The professional services of the Company shall be carried out only through its members, officers, employees, and agents, each of whom is duly licensed or otherwise qualified to render such professional services in the State of Florida.

ARTICLE III

Address. The mailing address and street address of the principal office of the company shall be 1115 East Concord Street, Orlando, Florida 32803.

ARTICLE IV

Duration. The Company shall commence its existence at upon the filing hereof. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in the operating agreement of the Company.

ARTICLE V

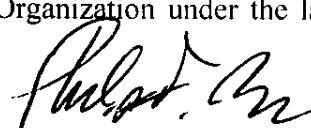

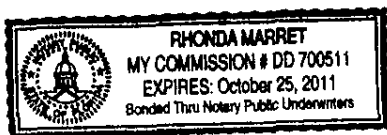

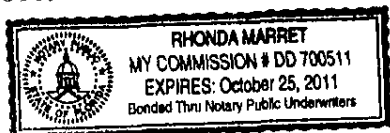
