ARTICLES OF ORGANIZATION
OF
OSBORNE & OSBORNE, P.L.

The undersigned, being a duly authorized person, desiring to form a professional limited liability company under and pursuant to Chapter 621, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I
DURATION

OSBORNE & OSBORNE, P.L., shall exist perpetually or until dissolved in a manner provided by law, or as provided in the Operating Agreement adopted by the members.

ARTICLE II
NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the professional limited liability company shall be OSBORNE & OSBORNE, P.L., and its principal and mailing office shall be located at 798 SOUTH FEDERAL HIGHWAY, SUITE 100, BOCA RATON, FLORIDA 33432, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

ARTICLE III
INITIAL REGISTERED OFFICE AND REGISTERED AGENT

ARTICLE IV
MANAGEMENT

The Company is to be managed by its members and is, therefore, a member-managed company.

ARTICLE V
PURPOSES AND POWERS

The general nature of the professional services to be rendered by this professional limited liability company shall be as follows:


