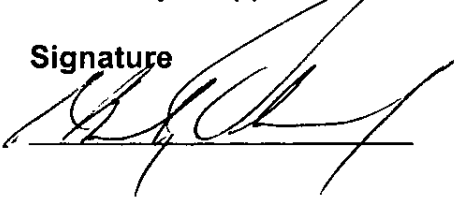
1. The name of the limited liability company is "**OSBORNE & OSBORNE, P.L., A FLORIDA LIMITED LIABILITY COMPANY**".
