ARTICLE I - Name:

The name of the limited liability company is M & R Pinecrest, LLC (the "Company").

ARTICLE II - Address:

The Company is to be a member-managed company.

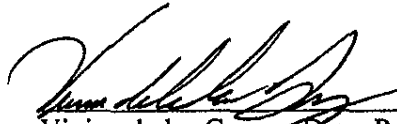
ARTICLE VI - Admission of Additional Members:
