The name of the Company is Lake Mary Leasing, LLC.

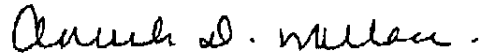

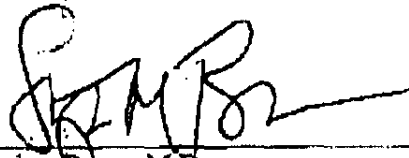
