### ARTICLES OF ORGANIZATION

# ARTICLE II PURPOSES AND POWERS

To enter into and make all necessary contracts for its business with foreign, or of any domestic or foreign state, government, or governmental authority, or of any political or administrative subdivision, or department, and to perform and carry out, assign, cancel, or rescind any of such contracts.
- 5. #### **EXERCISE OF POWERS**
