ARTICLES OF ORGANIZATION

OF

AREAL FLORIDA INVEST, L.L.C.

The undersigned, being authorized to execute and file these Articles of this Limited Liability Company pursuant to Chapter 608 of the Florida Statutes, hereby forms a limited liability company under the laws of the State of Florida and adopts the following Articles of Organization for such Limited Liability Company:

ARTICLE V - REGISTERED OFFICE AND REGISTERED AGENT

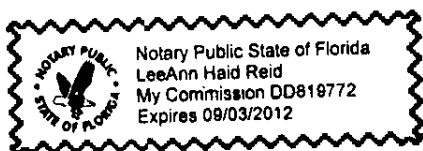

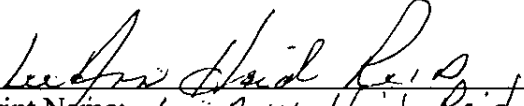
