

#### ARTICLES OF ORGANIZATION

OF

3002, LLC



#### **ARTICLE 1: NAME**

The name of the limited liability company is 3002, LLC (the "Limited Liability Company").

#### ARTICLE II: ADDRESSES

The mailing address of the Limited Liability Company is 430 Belle Point Drive, St. Pete Beach, Florida 33706. The street address of the principal office of the Limited Liability Company is 430 Belle Point Drive, St. Pete Beach, Florida 33706.

#### **ARTICLE III: DURATION**

#### ARTICLE IV: PURPOSE

The purpose for which the Limited Liability Company is being formed is to engage in any activity or business permitted under the laws of the United States and State of Florida.

#### ARTICLE V: REGISTERED AGENT AND OFFICE

The Limited Liability Company designates 430 Belle Point Drive, St. Pete Beach, Florida 33706, as the street address of the initial registered office of the Limited Liability Company and names Richard E. Carroll, 430 Belle Point Drive, St. Pete Beach, Florida 33706, as the Limited Liability Company's initial registered agent at that address to accept service of process within the State of Florida.

#### **ARTICLE VI: ADDITIONAL MEMBERS**

Additional Members of the Limited Liability Company may be admitted upon the approval of all of the Members of the Limited Liability Company and otherwise in the manner set forth in the Operating Agreement of the Company.

#### ARTICLE VII: MANAGEMENT

The Limited Liability Company shall be conducted, carried on and managed by no less than one (1) Manager, who shall be elected by the Members of the Limited Liability Company in the manner prescribed by and provided in the Regulations of the Limited Liability Company. Such Managers shall also have the rights and responsibilities described in the Regulations of the Limited Liability Company. The name and address of the initial Manager is as follows:

#### ARTICLE VIII: OPERATING AGREEMENT

The power to adopt, alter, amend or repeal the Operating Agreement of the Limited Liability Company shall be initially vested in the Members of the Limited Liability Company and thereafter in the manner prescribed by and provided in any adopted Operating Agreement of the Limited Liability Company.

### ARTICLE IX: LIMITATION ON AGENCY AUTHORITY OF MEMBERS

Pursuant to section 608.4235 of the Florida Limited Liability Company Act, no Member of the Limited Liability Company shall be an agent for the Limited Liability Company solely by virtue of being a Member, and no Member shall have authority to incur debt or contractual liability on behalf of the Limited Liability Company solely by virtue of being a Member.
