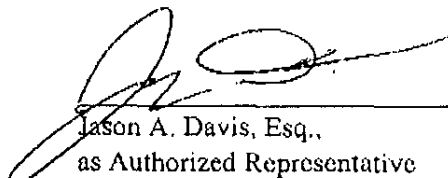

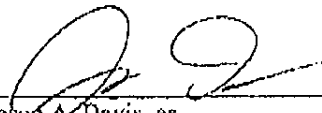
ARTICLE V MANAGEMENT

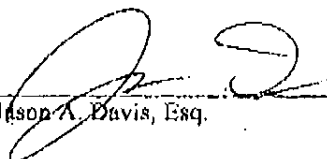
