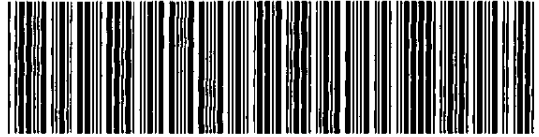




**Article VIII.
