ARTICLE VI - MANAGEMENT

The remaining members of the professional limited liability company may continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member in the professional limited liability company.
