THESE AMENDED & RESTATED ARTICLES OF ORGANIZATION (the "*Amended & Restated Articles*") of STEVE TUFTS VOLUSIA REO, LLC, a Florida limited liability company (the "*Company*"), are submitted in accordance with §608.411(4) of the Florida Limited Liability Company Act (the "*Act*") for purposes of amending and restating the Articles of Organization of the Company in their entirety. 


