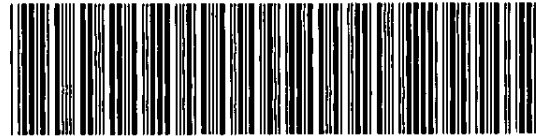

Pursuant to the provisions of section 608.441, Florida Statutes, this limited liability company adopts the following Articles of Dissolution to its Articles of Organization:

FIRST: The name and address of this Company is **J&D GLOBAL ENTERPRISE LLC**, 23536 124th Terrace, Live Oak, Florida 32060.

SECOND: The date of the adoption of these Articles of Dissolution is 6 June 2012.

THIRD: The dissolution of the Limited Liability Company was a unanimous agreement of all members.
