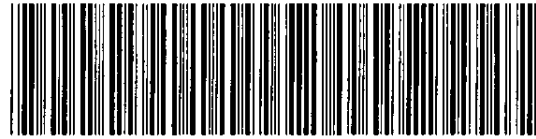

The undersigned, for the purpose of forming a limited liability company under the Florida Professional Limited Liability Company Act, Florida Statutes Chapter 621, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the professional limited liability company shall be **HARRIS & STUTCHIN PROFESSIONAL LIMITED COMPANY**, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 1375 Jackson Street, Suite 202, Fort Myers, Florida 33901 and the mailing address shall be the same.


